#### 1. Background

In 2022, the Africa Centers for Disease Control and Prevention issued a Call to Action for Africa’s New Public Health Order, underscoring the need for increased capacity in the public health workforce. Additional domestic and global investments in public health workforce development are crucial to achieving the aspirations of Agenda 2063, the African Union's vision, which aims to build and accelerate the implementation of continental frameworks to foster equitable, people centered growth and development. Higher education and research in public health are critical for addressing the burden of disease in Africa and globally. Recognizing the pivotal role of higher education and research, the Africa Research, Implementation Science, and Education (ARISE) Network evaluated the capabilities of public health doctoral training in African schools and programs across three domains: instructional, institutional, and external. Six interrelated and actionable recommendations were derived to advance training, research, and practice capacity within and between universities. These can be achieved through partnerships among universities, research centers, national and sub-national public authorities, including public health and health sector organizations, as well as regional and global partners. We aim to develop a collaborative research, training, and workforce development program that translates these recommendations into action through south-to-south collaboration and experience sharing.

The Addis Continental Institute of Public Health will lead the collaboration with the Africa Academy for Public Health (AAPH). The ARISE Network that include institutions from Ethiopia (Addis Continental Institute of Public Health; Haramaya University), Ghana (University of Ghana), Nigeria (University of Lagos; University of Ibadan Research Foundation), South Africa (University of Witwatersrand, University of Cape Town, University of KwaZulu-Natal, and Africa Health Research Institute), Tanzania (Muhimbili University for Health and Allied Sciences and Africa Academy for Public Health), Burkina Faso (Nouna Health Research Centre), Rwanda (University of Global Health Equity and University of Rwanda), Botswana (University of Botswana), Senegal (Institut Pasteur), and Uganda (Makerere University School of Public Health and Mbarara University of Science and Technology) along with Harvard T.H. Chan School of Public Health in the US and Heidelberg Institute of Global Health in Germany have been working collaboratively to address issues of workforce enhancement, addressing pandemic issues, and the growing challenges of adolescent health for over a decade. The ARISE network brings together a multidisciplinary team of researchers and public health practitioners with in-depth experience and expertise in research training and capacity building, with a strong emphasis on a South-to-South collaboration.

With support from the Health Development Partnership for Africa and the Caribbean (HeDPAC) The ARISE Network seeks to engage an Entrepreneurship and Innovation Expert for dialogue facilitation and the

development of innovative solutions to the workforce challenges the African continent faces in delivering routine health services, and to better prepare the continent to respond to pandemic threats appropriately and in a timely manner. The challenges are currently exacerbated by the sudden withdrawal of international aid in almost all countries and the conflict in Western Asia, making self-sufficiency, which was advocated in the Primary Health Initiative in 1978, a formidable socioeconomic challenge for the countries in the South. The consultant shall provide technical support at convenings of the ARISE Network members and develop a long-term plan to sustainably accelerate health workforce development and job creation in the ARISE countries and beyond. Ultimately, the consultant will facilitate development of pathways for integration of young people, including women and girls, into the civil service workforce.

## **2. Scope of the Consultancy**

The consultant will support development of a practical framework for expanding new job creation, focusing on innovation, service delivery, and commercialization. The consultant will also advise on opportunities to engage with the private sector and other key stakeholders to strengthen innovation ecosystems, support venture development, avail capital investment, and expand pathways for job creation. In this, the consultant will:

- 2.1 Work closely with the ARISE leadership team and the Operational Support Expert Consultant to ensure a wide range of new job creation modalities are integrated into the overall program design and narrative.
- 2.2 Provide strategic and technical guidance to develop entrepreneurship and innovation training during college and immediately after college that will equip the new workforce with entrepreneurial skills and innovations, catalyzing job creation. This may include recommendations for curriculum components, training modules, experiential learning opportunities, mechanisms for mentorship, venture incubation, and innovation support.
- 2.3 Assess the national landscape in participating countries (up to 5) including relevant systems, entrepreneurship and innovation ecosystems, policies, laws, and regulatory frameworks thereof with possible pathways for creating new jobs at scale.
- 2.4 Coordinate closely with the Operational Support Expert Consultant to review and provide substantive feedback on program design and narrative sections related to new job creation strategies to ensure demonstration of feasibility and sustainability.

The consultant will provide recommendations and technical input, but final programmatic decisions will remain with the ARISE leadership team.

## **3. Duration and Reporting**

The consultancy shall be for a duration of up to 4 months. The consultant will report to the ARISE leadership team through the CEO at Africa Academy for Public Health, and work in close coordination with designated institutional leads responsible for proposal development and strategic decision-making.

## **4. Desired Expertise and Qualifications**

The consultant should demonstrate the following qualifications and experience:

- 4.1 Advanced degree related in business administration, entrepreneurship, innovation management, economics, public health, or a related field (at least master's degree, or equivalent).
- 4.2 Demonstrated experience designing or implementing entrepreneurship or innovation training programs, particularly within universities or research institutions.

- 4.3 At least 5 years of relevant professional experience supporting entrepreneurship, innovation ecosystems, startup development, or venture incubation.
- 4.4 Expertise in health innovation, public health entrepreneurship, or health technology ventures, particularly in low- and middle-income country contexts.
- 4.5 Strong knowledge of African innovation ecosystems, including accelerators, incubators, venture capital networks, and innovation hubs.
- 4.6 Experience supporting research translation, commercialization, technology transfer, or startup development arising from academic or research institutions.
- 4.7 Familiarity with policy, regulatory, and institutional environments affecting entrepreneurship and innovation in African countries.
- 4.8 Demonstrated ability to build partnerships with private sector actors, investors, industry partners, and innovation ecosystem stakeholders.
- 4.9 Experience advising universities, global health programs, or development initiatives on entrepreneurship, innovation strategy, or workforce development.
- 4.10 Strong communication and facilitation skills, with the ability to work collaboratively with multidisciplinary teams across academic, government, and private sector stakeholders.
